1. Find your email invitation to vote.

a. Click: Other Proxy Holder

c. Click: 3 YEARS

NOTE: Because you are assigning your proxy to WM Owners, you are not voting for any names.

6. Review and submit your entry.

It should include:

a. Appointment of WM Owners, INC.

b. Length of time for proxy of 3 years.

Note: You will be able to vote or reassign your proxy next year or any year, but your proxy will remain valid for three years if you don't choose to vote or change it. I assign mine to WM Owners every year... just in case!

c. To receive confirmation, enter your email address if it is blank.

d. Click: SUBMIT
